

# ASA Stats Transparency Report

for June 2025

The creator of this report is Ivica Paleka. He is the keeper of the ASA Stats development pool in the pre-DAO phase and will be referred to as the Keeper for the rest of this report.

## Administration and costs

VPS subscription for two servers provided by OVH was paid US\$61.82 on Monday, Jun 2<sup>nd</sup>. The invoice with credential reference WE3875141 will be uploaded to the designated public repository created under the [ASA Stats GitHub organization](#), just before custody of the ASA Stats project is transferred to the ASA Stats DAO.

Monthly usage for EX44 Dedicated Server provided by Hetzner was paid 55.00 € on Tuesday, Jun 3<sup>rd</sup>. The invoice with credential reference 080000297176 will be uploaded to the designated public repository created under the [ASA Stats GitHub organization](#), just before custody of the ASA Stats project is transferred to the ASA Stats DAO.

On [Mon, 16 Jun 2025 12:42:00 UTC](#), the Keeper sent 100.00 ALGO from the *devpool* to the newly created Community Liquidity escrow:

The Community Liquidity escrow will be used for creating [joint Liquidity Pool with Pact](#), as well as receiving and allocating the fees and possible rewards to the participants.

On [Mon, 16 Jun 2025 23:37:31 UTC](#), the Keeper sent 100.00 ALGO from the *devpool* to the newly created *dualSTAKE* escrow:

The *dualSTAKE* escrow will be used as the administration account for the Algorand Node instance that will be run to support the ASASTATS-based *dualSTAKE* token.

On [Mon, 16 Jun 2025 23:42:17 UTC](#), the Keeper sent 20.00 USDC from the *devpool* to the *dualSTAKE* escrow.

On [Mon, 16 Jun 2025 23:55:45 UTC](#), the Keeper sent 20.00 USDC from the *dualSTAKE* escrow to the Myth Finance account as the fee for creation of [astatsALGO token](#).

The Keeper prepared a dedicated Node instance, created participation keys for *dualSTAKE* smart contract escrow, and on [Tue, 17 Jun 2025 15:07:09 UTC](#) assigned it to go online in Algorand consensus. A fee of 2.00 ALGO was spent for the purpose.

On [Sun, 22 Jun 2025 16:10:03 UTC](#), the Keeper sent 2,500,000 ASASTATS from the Manager account to Pact escrow. Those funds will be allocated in July as additional rewards for contributors to the ALGO/ASASTATS liquidity pool on Pact, which is qualified as a consensus-based pool.

On [Sun, 27 Jun 2025 22:56:02 UTC](#), the Keeper sent 95,000,000 ASASTATS from the Manager account to the Pact escrow for the purpose of creating [joint Liquidity Pool with Pact](#). On [Mon, 28 Jun 2025 09:31:17 UTC](#), a Pact official supplied 95,000,000 ASASTATS and 888,000 POW to the ASASTATS/POW LP on Pact and received 9,184,770 ASASTATS/POW PACT LP tokens. It is expected that a half of those tokens will be allocated to the Manager account and that the Keeper locks them for a period of one year.

## Tokenomics

For the rest of this document, it is implied that all the transactions are created by the Keeper.

### Development Pool

On [Thu, 04 Jun 2025 22:21:22 UTC](#), the Keeper sent 2,000.00 ALGO from the *devpool* to the Team's Nexo account. It is expected that those funds would be spent by the *admpool* and the Team in the following period.

On [Mon, 16 Jun 2025 18:24:16 UTC](#), the *devpool* unstaked 20,435.29 ALGO from the NFDomains validator on the Réti Pooling platform.

From [Mon, 16 Jun 2025 18:32:14 UTC](#) to [Mon, 16 Jun 2025 18:35:02 UTC](#), the Keeper sent 47,500,000 ASASTATS from his private account to the *devpool* for the purpose of joint participation in the Tinyman2 ASASTATS-ALGO LP.

On [Mon, 16 Jun 2025 18:36:46 UTC](#), the *devpool* provided 47,369,681 ASASTATS and 15,000.00 ALGO to the Tinyman2 ASASTATS-ALGO LP and received 813,317.74 TMPOOL2 tokens.

On [Mon, 16 Jun 2025 23:41:49 UTC](#), the *devpool* swapped 98.65 ALGO on Tinyman2 and received 18.09 USDC.

From [Tue, 17 Jun 2025 14:44:59 UTC](#) to [Tue, 17 Jun 2025 15:08:28 UTC](#), the Keeper on behalf the *devpool* sent 10,000.00 ALGO through the dualSTAKE platform and received 10,000.00 astatsALGO tokens in return.

### Giveaway Pool

From [Wed, 18 Jun 2025, 21:34:15 UTC](#) to [Wed, 18 Jun 2025, 21:35:28 UTC](#), the Keeper on behalf *givpool* removed liquidity from Tinyman2 ASASTATS-tALGO LP and added adequate liquidity to the Tinyman2 ASASTAST-ALGO LP. A total of 22,164.77 TMPOOL2 ALGO/ASASTATS LP tokens was allocated to the *givpool* in the process.

## Joint Pool

From [Mon, 16 Jun 2025, 17:55:30 UTC](#) to [Mon, 30 Jun 2025, 06:10:47 UTC](#), a total of 87,115,687 ASASTATS was allocated to the ASA Stats Joint Pool by the 22 contributors. It is expected that those 22 contributors share the rewards allocated to the Joint pool.
