

# ASA Stats Transparency Report

for September 2025

The creator of this report is Ivica Paleka. He is the keeper of the ASA Stats development pool in the pre-DAO phase and will be referred to as the Keeper for the rest of this report.

## Administration and costs

VPS subscription for two servers provided by OVH was paid US\$61.82 on Tuesday, Sep 2<sup>nd</sup>. The invoice with credential reference WE3976103 will be uploaded to the designated public repository created under the [ASA Stats GitHub organization](#), just before custody of the ASA Stats project is transferred to the ASA Stats DAO.

Monthly usage for EX44 Dedicated Server provided by Hetzner was paid 55.00 € on Wednesday, Sep 3<sup>rd</sup>. The invoice with credential reference 080000476570 will be uploaded to the designated public repository created under the [ASA Stats GitHub organization](#), just before custody of the ASA Stats project is transferred to the ASA Stats DAO.

On [Wed, 24 Sep 2025 17:54:38 UTC](#), the Keeper sent 2,000,000 ASASTATS from the Manager account to Pact escrow. Those funds will be allocated in October as additional rewards for contributors to the ALGO/ASASTATS liquidity pool on Pact, which is qualified as a consensus-based pool.

On Wednesday, September 10<sup>th</sup> the Keeper purchased the Apple Developer Program membership for another year by transferring an amount of 99.00 USD to Apple Inc. The invoice with number MC00591931 will be uploaded to the designated public repository created under the [ASA Stats GitHub organization](#), just before the publishing of ASA Stats software as open-source.

## Community Liquidity Pool

## Airdrop Pool

An amount of 618,034 ASASTATS was transferred on [Mon, 08 Sep 2025, 16:52:29 UTC](#) from the Manager address to the *airpool* for the [DAO Airdrop](#) purpose.

### *ASA Stats DAO Airdrop*

On [Mon, 08 Sep 2025, 17:00:05 UTC](#) the *airpool* sent 618,034 ASASTATS to one new governor from ASA Stats community to their governor seat address.

## Giveaway Pool

An amount of 500,000 ASASTATS was transferred on [Mon, 08 Sep 2025, 16:54:05 UTC](#) from the Manager address to the *givpool* for the [DAO Giveaway](#) purpose.

### *ASA Stats DAO Giveaway*

As defined in the [Governor Seats Update 2024-09-06](#), the listed governor from the Algorand community receive the funds for their seat's votes in the DAO Giveaway.
